## Guarantees:

- Breeder guarantees the dog described is a purebred Dachshund with AKC registered parents.
  - Breeder guarantees the dog is in good health at the time of purchase.
  - Breeder does not guarantee adult size, conformation, color, or temperament.

## Health Agreement:

The buyer agrees to the following terms and conditions:

- **Initial Health Evaluation:**  
The buyer must take the puppy to a veterinarian within 3 business days for the health guarantee to be in effect. If not completed within this time frame, the breeder is under no obligation for refunds or returns. Any health issues identified must be reported immediately, excluding worms and bacterial infections like coccidia and giardia.
  - **Return Policy:**  
If the buyer regrets taking ownership of the puppy, it may be returned, but no refund or exchange will be issued. The breeder is not responsible for vet costs after the puppy leaves the premises.

## Extended Guarantee:

- The breeder guarantees against congenital life-threatening disorders for **one year**. This guarantee covers **heart, kidney, liver & hip dysplasia** (confirmation from a licensed veterinarian is required).
- 

## Conditions Not Covered:

- The guarantee does not cover kennel cough, allergies, stress-related issues, bacterial infections, or environmental diseases.

## Replacement Policy:

If a life-threatening genetic defect develops, the breeder will provide a replacement puppy of equal value from the next available litter. No monetary refunds will be issued, and the buyer will cover shipping expenses.
